## Retreat

A significant business meeting was held Saturday morning reviewing 2021's accomplishments and projections for 2022.

One of the obvious changes from last year is the collaboration with the Pinehurst/Kingston Lyons Club which several board members have joined. Since their meetings follow SVFCH's scheduled board meetings on the 2<sup>nd</sup> Tuesdays of the month, it was logical to start holding all board meetings at the Lyons Club's hall and also this year's retreat meeting. The two organizations will share responsibility for publicity and helping with fund raising events.

One of the duties of SVFCH is to create a budget projection for the current year. The Finance Committee is in charge of that duty. That committee also decided it was time to review the contracts with homeowners who are

making mortgage payments to see how changes in taxes and insurance are affecting the equity on their homes. The original mortgage contracts cover withholdings to pay taxes and insurance on their property which insures they will not become delinquent. However, with the increase in both taxes and insurance premiums over the years, some homeowners' equity has not kept pace.

At this time there are 3 Greater Blessings projects projected to be worked on this spring/summer and, of course, more are expected. We are relying on Clint Kunze with the Idaho Servant Adventurers and AmeriCorps to provide some valuable workers. Clint attended the retreat meeting and explained how the first project many be "manned" with the AmeriCorps folks who will be arriving early He gave the dates in June through the first part of August when the large groups of youth arrive at Shoshone Mountain Retreat and will subdivide into smaller groups to help with multiple projects in our valley.

It will be fantastic to have help again with this organization. Two years ago all was cancelled due to COVID. Last year the forest fires overtook the area and the firefighters stayed at the retreat which had originally been a Forest Service Base Camp. If you have projects where you would like help they can do (such as painting, yard work, etc.), you can contact us for a Greater Blessings application and we can send it on to Clint. The youth are restricted from going too high on ladders, etc., which are considered risky under child labor laws, but we may have other volunteers.




