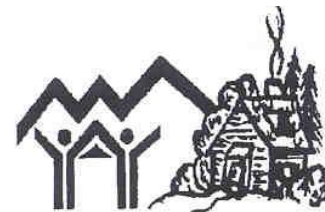

### Earthquake victims need help

#### The Silver Valley Fuller Center for Housing (formerly Silver Valley Habitat) is accepting donations for long-term earthquake recovery in Haiti.

The Fuller Center will begin building simple, practical homes as soon as possible, breaking ground as soon as emergency teams have completed their missions. Working with other organizations to procure buildable land, the center plans to erect small (about 900 square-foot) earthquake and fireproof homes for less than \$4,000 each.

As with the Hurricane Katrina disaster, the local group will forward donations to where they are most needed: exclusively for Haitian homes. Contributions can also be submitted online at the Fuller Center's Web site, [www.fullercenter.org](http://www.fullercenter.org), by following the links. The center will also be organizing work parties to physically construct the homes.

David Snell, president of the nationwide Fuller Center organization, released a statement Friday regarding the Haitian tragedy.

"The Fuller Center is not a disaster-relief organization," Snell said, "but we have a very important role to play in the longer-term response to this crisis. We build houses — simple, decent homes that provide a safe, secure place for families. We expect to be heavily involved in Haiti, once the situation there stabilizes and reconstruction work can begin."

He concluded his statement with a call for help:

"It's the basic nature of charitable work that we seem to always have our hand out, asking for support," Snell said. "But the good work we do wouldn't be possible without that support. We believe the Haiti earthquake is a special call to people of good will. We do appreciate your generous support." For local contributions please send a check to SV Fuller Center for Housing, PO Box 874, Kellogg, ID 83837; please include a note that specifies the donation is for Haiti. None of the collected funds will go toward the organization's administrative costs.

### Haitian Help Update

The Fuller Center will build homes in Haiti in partnership with Lazarian World Homes--beginning as early as March.

Lazarian World Homes designed a 16'x16' home using styrofoam blocks, concrete and rebar that can be built for just \$3,000. The first two homes are ready to go and will be shipped as soon as possible to serve as a temporary clinic and an office/model home.

"We are pleased to be using the Lazarian World Home design," Fuller Center President David Snell said. "It is well-engineered, is earthquake-, hurricane- and fire-resistant, is very easy to build, and has components that can be made in the nearby Dominican Republic."

## Construction Site Reports

### The Sunny Slopes Lake Site

In January we finished mudding, texturing and painting the sheetrock. [A special thanks is due Jim Taylor of Taylor Made Construction for supervising the texturing crew.] By the time you read this, the electrical will be done and perhaps the gas furnace running.

The Lake family is grateful for the help their friends, especially the volunteers Mike Humphrey, Charkoosta Wickstrom, Christopher Leetch, Richard Brown, and Tracy Cannaday; the hopeful home-owners-to-be, Darnell Kriedeman and Amethyst Pelham; the site supervisors, Bob Larson and Kevin Hutchings; and Swede Little from "Experience Works."

In February, the cabinets may be finished as well as the laying of the wood flooring.

### The Little Shop Project

Also in February, we may finish painting the inside of the Little Shop as Pat Elfsten of Furniture Exchange allows us to use his electricity to heat the little building—Thanks, Pat. (It won't take much as the building is insulated.)

Then we will finish the electrical, followed thereafter by the wood flooring and shelving. It's going to be nice!

### The Mullan Home

In January, Kevin and Swede constructed a second wall in the back bedroom and intend on lowering the ceiling to eight feet to further insulate the building. When they finish that and finish the accompanying rough electrical, we'll have the "rough in" electrical inspected.

### Greater Blessing Activities

Our Greater Blessing program handles repairs for small projects for needy homeowners as we can afford it. When the project is finished and all the bills come in, we give them a small box (The Greater Blessing Box) with return envelopes in it. They pay us back as they are able to.

Initially we had the Family Selection Committee handle the Greater Blessing applications. However, at the January meeting, the Board decided to streamline the process by allowing the Site Supervisor who sees if the project is feasible (financially and worthwhile) to make the call. Then it must be approved by the Board.

The first site visits that we made were determined to be either too extensive or bad investments. However, Bob Larson found a desirable porch to be covered in Wallace that we'll do when the weather warms up, and Kevin found a worthy bathroom repair project at the Silver Valley Assembly of God Church in Kellogg. This project was especially appropriate for all as the Church has let us use their facilities in the past. Kevin and Swede did a swell job on that project.
