One of the foundation blocks of Habitat for Humanity in the Silver Valley, Janet Lake has been on the

Board from its beginning, serving on the Family Selection Committee. Janet called Father King at St. Rita's Church in connection with her work with Shoshone County Head Start, to ask about available shelter for homeless folks, and he told her about Habitat and she became interested. She worked along with Pastor Kate Lepard in getting organized, and she became chair of the Family Selection Committee almost from the beginning. Janet was born and reared in Kellogg, graduating from KHS and attending Kelsey-Baird Secretarial School in Spokane. She and her husband, Marvin, have been active with their three boys in the scouting program from the time

she was a Den Leader for six years; Marvin was scoutmaster of Troop 355 for many years, and served on the district level in many capacities. Janet also has served on the Shoshone County Youth Accountability Board, helping troubled youth.

Twenty-three years ago she began working with Shoshone Head Start as a teacher-aide, and soon became a teacher, a teacher consultant, a family services coordinator, and is currently the principal for the program.

Habitat for Humanity and the entire community is very fortunate to have a person of Janet's caliber who has demonstrated so much service for so many years. Janet's placid persistence and cool wisdom have enriched the lives of many in our valley.
